	Заоре	This approval is based on industry standard JIS 2320:2003 "Ships' Oiltight Hatch Covers". Hatch cover parts/components and their dimensions, material specifications and welding shall be as mentioned in this standard or shall be equivalent.
		Each hatch cover shall be marked as required by Proposal to Owner CZV-000-MA-RE-1011.
		In addition to tests mentioned in this document, each hatch cover shall be function tested after installation onboard.
		It is understood that these hatch covers are used to cover access hatches for inspection of cargo tanks as shown in Drg. No. CZV-000-HS-LA-1061-01. It is assumed that these hatches are not emergency escape hatches. If this assumption is not correct, additional requirements in Ship Rules Pt.3 Ch.3 Sec.6 B400 shall be complied.
		It is assumed that these hatches are not immersed by an equilibrium or an intermediate water plane in damaged condition. If this assumption is not correct, hydrostatic pressure test is to be carried out as per Ship Rules Pt.3 Ch.3 Sec.6 A504.
		This approval is vessel specific and intended only for DNV GL vessel Id 35703 for afore-mentioned location and purpose.
